I. **PROJECT MANUAL**

A. **SECTION 00 10 00; NOTICE TO BIDDERS**

1. **Delete** first paragraph and **Add** new first paragraph to read as follows:

“Notice is hereby given that sealed bids will be received by the Mount Laurel Township Municipal Utilities Authority, for Door and Window Replacement, Various Building Locations, Contract No. 2020-05, and will be opened and read in public at the Authority Office, 1201 South Church Street, Mount Laurel, New Jersey 08054 on **Thursday, November 12, 2020 at 10:00 A.M., prevailing time.** Bids will also be received in person at the above noted date and time at the Authority’s Elbo Lane Water Treatment Plant located at 41 Elbo Lane, Mount Laurel, New Jersey 08054. As soon as possible thereafter the bids received will be opened and publicly read in the large conference room at the Elbo Lane Water Treatment Plant, 41 Elbo Lane, Mount Laurel, New Jersey 08054. All Non-Employees (Visitors) entering an Authority facility will be required to complete a COVID-19 Visitor Assessment Log, wear a face covering or mask and maintain a minimum of six feet (6’) between themselves and any Authority employee.”
